



**Pinewood Christian Academy Family Covenant**

I. Spiritual Partnership

I/We recognize that children are trained spiritually first and foremost in the home. For this reason, I/we affirm that at least one parent is a professing Christian, trusting in Jesus Christ alone for salvation, adhering to the basic precepts of historic, orthodox Christianity, and regularly attending a local protestant, gospel-teaching church.

I/We agree that the foundational relationship in the covenant family is that of husband (i.e. one man) and wife (i.e. one woman) according to Genesis 2:18-25. I/We acknowledge that there will be times when I/we may be at odds with a PCA teacher, administrator, staff member, or other parent(s) and that dealing with such conflict publicly (e.g. gossip, social media, etc.) is potentially harmful to our school partnership, the PCA community in general, as well as the witness and reputation of PCA as a Christian school (see Galatians 5:13-15). Therefore, I/we commit to following the biblical principles of peacemaking and reconciliation as set forth in Matthew 18:15-17 in all of my/our interactions, with the understanding that all other PCA faculty, administrators, staff, and families commit to doing the same.

III. Financial Partnership

I/We acknowledge that PCA is wholly dependent on families paying tuition to fulfill its financial obligations and operating expenses. I/we therefore commit to arrange for full payment of the tuition and fees described in the 2018-2019 Tuition and Fees Schedule.

I/We acknowledge that the Session of Pinewood Church and the Academy Ministry Team have determined that in order to completely fund the education of each PCA student in grades K-8 an additional \$300 per child is needed above tuition and fees. These additional funds come primarily through four annual fundraising events including: Scholastic Book Fair; Columbus Day Golf Tournament; Family Dinner, Auction, and Mega Ticket Drawing; and Race for Education. Since all PCA students benefit from fundraising, I/we commit to attending, assisting with, participating in, and promoting these events unless providentially hindered.

\*Alternatively, in lieu of participating in fundraising events, I/we may donate \$300 to the school for each child in grades K-8 that I/we have enrolled to help achieve the yearly fundraising goal.
