We acknowledge that there may be times when we are at odds with a PCA teacher, administrator, staff member, or other parent(s) and that dealing with conflict publicly (e.g. harassment, gossip, social media, etc.) is potentially harmful to individual relationships, the school community in general, and the witness and reputation of PCA as a Christian school (see Galatians 5:13-15). Therefore, we commit to following the Biblical principles of peacemaking and reconciliation established by Jesus in Matthew 18:15-17 and by the Apostle Paul in 1 Corinthians 6:1-8.

We agree to actively support the faculty, administration, and staff as we work together to provide our child(ren) with an excellent education in an environment that emphasizes compassion and responsibility. This includes, but is not limited to, providing daily support and accountability for our child(ren)'s academic success, complying with disciplinary practices, and upholding the Biblical values that are foundational to all school policies and practices.

We acknowledge that the Parent-Student Handbook contains the standard operating policies and procedures for students, parents, faculty, administration, and staff at PCA; and that its purpose is to not only ensure that the school operates smoothly, but also honor and protect the dignity of all members of the PCA community. We therefore commit to abiding by the policies and procedures in the Parent-Student Handbook and, by our example, encouraging our child(ren) to do the same.

We acknowledge that PCA is dependent on families keeping their accounts current to fulfill its obligations and expenses. We therefore commit to arrange for full payment of all tuition and fees accrued monthly.
